Join Woodfords and Disability Rights Maine to discuss Supported Decision Making (SDM)—a guardianship alternative. SDM is a method of developing decision-making skills by relying on a team of supporters to assist an individual in coming to a reasoned decision.

Under the SDM model, an individual with a disability identifies areas where they need help—budgeting, health care, housing, jobs, or relationships. They then choose supporters to provide decision-making help in these areas. SDM

promotes self-determination, control, autonomy and fosters independence. Come learn about SDM and how to create a plan.

Sexuality & Boundaries

Discussing sexuality and personal boundaries with children can be difficult for even the most confident parents. It can be even more challenging to have these conversations with children and adolescents with developmental disabilities. Because research shows that children with developmental disabilities are at a higher risk of being sexually abused or exploited, it is important that parents educate their children about their bodies, how to set personal boundaries and how to stay safe.

This three-hour training will provide participants with some basic tools and language to facilitate healthy discussions and education around sexuality and boundaries.

Understanding Trauma

This training will provide parents, foster parents, care providers and professionals with an understanding of trauma and its potential effects on children, as well as the coping strategies often used by children who have experienced trauma.

Also discussed will be the importance of self-care, developing strategies for preventing burnout and secondary traumatic stress, as well as ways to build resilience in children and families.

Safety-Care for Families Skills for Managing Challenging Behaviors

This course provides parents, family members and caregivers with the skills, interventions and confidence needed to improve behavior and to prevent, minimize and manage potentially dangerous incidents. The Safety-Care for Families curriculum consists of four, three-hour sessions. Essential Skills are presented in a lecture format while Advanced Skills are trained in a small group for individualized instruction. ***This training is free to families currently receiving services through Woodfords.*** For all others the fee is \$25 per session.

Essential Skills, Part I - Wednesday, October 9, 2019, 5:30 to 8:30 p.m.

Topics: Collaboration w/ professionals, legal issues, challenging behavior, reinforcement, safety habits, elbow check, safety stance, managing your own behavior, differential reinforcement

Essential Skills, Part II - Wednesday, October 16, 2019, 5:30 to 8:30 p.m.

Topics: Antecedents to challenging behavior, triggers, signals, basic principles of de-escalation, development of a comprehensive family safety plan

Advanced Skills*, Part I - Wednesday, October 23, 2019, 5:30 to 8:30 p.m.

Topics: Use of behavioral momentum to improve cooperation, advanced de-escalation strategies, management of weapons, basic physical safety skills, releasing from holds

Advanced Skills*, Part II - Wednesday, October 30, 2019, 5:30 to 8:30 p.m.

Topics: Emergency physical intervention, one-person stability hold, two-person stability hold (optional), releasing from stability hold, recovery and debriefing

The participant named has requested to attend **Safety-Care for Families**, a training for people who assist individuals who have the potential to engage in dangerous behavior. The initial training classes are open to any adults, and are required before participation in advanced training. The advanced classes include personal physical safety and physical holding techniques. These procedures are intended to be used only as a last resort, to enhance safety in the event that an individual with disabilities engages in very dangerous behavior. They do, however, present a risk of serious harm, especially if used improperly.
